The range of air freight service outlined below is provided in a choice of time-specific options including:

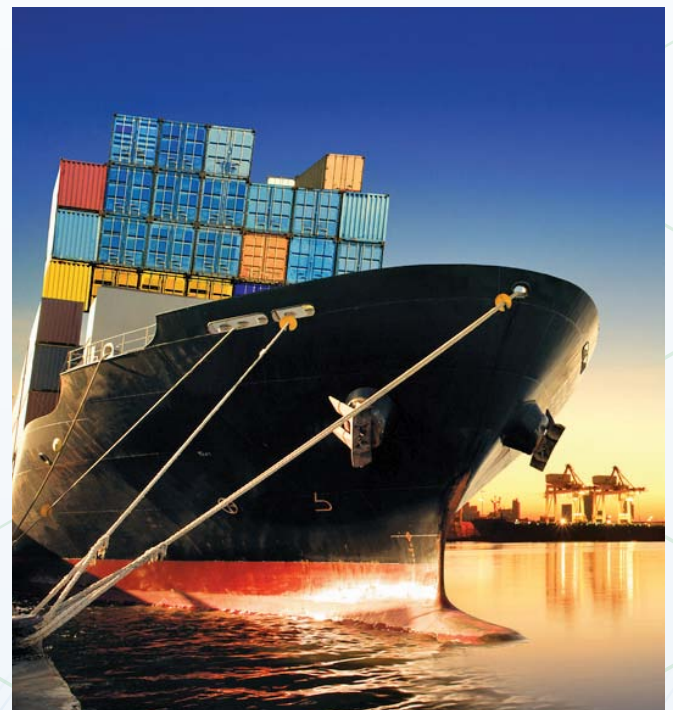
First class: the quickest air freight service available for urgent and time-sensitive shipments

Offshore consolidation, by the vendor or MOJM enables the importer to ship goods to the port of destination nearest to the end consumer. The 'low-hanging fruit' remaining in most supply chains is the opportunity to reduce the high cost of transport within the destination country or region.

Direct to store involves processing store orders in the country of origin where lower labour rates are prevalent. Our process includes receiving information from the vendor such cargo and transport documents to facilitate customs procedures at the destination deconsolidation point. MOJM will use various bar coding methods including Serial Shipping Container Code (SSCC) and destination carrier consignment labels.
